

COMMANDANT STANDS AGAINST GAYS IN MILITARY

The Commandant of the Marine Corps said Feb. 25 that gays should not be allowed to serve openly in the military, becoming the most senior commander to break from **President Barack Obama's** goal of lifting the ban.

Gen. James T. Conway, testifying before the Senate Armed Services Committee, said the policy known as "don't ask, don't tell" should be left alone.

"I think the current policy works,"

he said. "My best military advice to

this Committee, to the Secretary, to

the President, would be to keep the law such as it is."

Conway's stance is considered crucial because it shows there are sharp disagreements among top officers and within the Joint Chiefs of Staff about whether to allow gays and lesbians to serve openly. Opposition from military leaders helped derail earlier efforts to lift the ban, most notably former **President Bill Clinton's** effort in 1993.

Unlike previous attempts to ease

League Joins Marine Identity Cause

The Marine Corps League sponsored a Press Conference at the Rayburn House Office Building on Capitol Hill in Washington on Feb. 25. The purpose of the Press Conference was to kick off the "grass-roots" campaign to get the "Marine Identity Cause" Project signed into law.

"We had an "all-star" cast of speakers and guests present," explained Marine Corps League Executive Director Mike Blum, " including Congressman Walter Jones, Senator Pat Roberts, R. Lee Ermy, former Commandant of the Marine Corps Gen. Al Gray, former Assistant Commandant of the Marine Corps Gen. Robert Magnus, Gen. Tony Zinni, the League's Legislative Liaison LtGen. Stephen Olmstead, former Director of the Marine Corps' Office of Legislative Affairs BrigGen. Terry Paul, Sgt. "Eddie" Wright, a Marine who lost both his hands in Iraq, and others including a father who had lost his Marine son in Iraq and the Marine Mom who founded MarineParents.com.

H.R. 24 now has 368 co-signers in the House of Representatives.

"The problem is in the Senate," says Blum. "**Sen. Pat Roberts** of Kansas (a Marine Corps Veteran) has in-

'IWO JIMA' MEMORIAL NEEDS REPAIR & EXPANSION

The Marine Corps War Memorial Foundation is calling on Marines for help.

On the morning of Feb. 23, 1945, AP photographer **Joe Rosenthal** captured an image of five Marines and a Sailor struggling to raise an American flag atop Mount Suribachi following four days of intense fighting on the Japanese-held Pacific island of Iwo Jima. It has been said that in that moment, Rosenthal's camera recorded the soul of a nation. His Pulitzer Prize-winning photograph forever immortalized the strength and determination of Marine forces that struggled for victory in one of the most intense and cost-

rules, however, top Pentagon officials have endorsed a change. Adm. Michael G. Mullen, the Chairman of the Joint Chiefs, said last month that he wanted a new policy and that allowing gays to serve openly was a matter of "integrity."

Republicans opposed to changing the policy have said that Mullen's views do not represent those of other senior military leaders.

The chiefs of the various military services have been testifying before the House and Senate, and lawmakers have questioned them about the Obama administration's plans to overturn the 1993 law that bars gays and lesbians from serving openly.

Since the law was passed, about 14,000 service members have been removed from the military because of their sexual orientation.

During their testimony, none of the chiefs backed Mullen's position by calling for an end to the ban. But all of the chiefs, including Conway, have supported **Defense Secretary Robert M. Gates'** plan to study the effect of changing of the law.

Conway has taken positions at odds

with top Pentagon officials in the past, but has not publicly addressed the issue of gays in the military.

Conway is due to retire this summer when his term as Commandant is up.

He told lawmakers that any policy change should not be judged by its fairness to gays, but by its impact on the military.

"My personal opinion is that unless we can strip away the emotion, agenda and politics and ask [whether] we somehow enhance the war-fighting of the United States Marine Corps by allowing homosexuals to openly serve, then we haven't addressed it from the correct perspective," Conway said.

troduced the Bill (S.204) in the Senate and it has two co-sponsors to date --Sen. Kay Hagen of North Carolina and Sen. Richard Burr of North Carolina.

Conway was challenged, gently, by **Sen. Joe Lieberman** (Conn.), who has said that he plans to introduce legislation to allow gays to serve openly.

"I hope we conclude that repealing 'don't ask don't tell' will enhance military readiness," Lieberman said.

Some advocacy groups were more direct.

Aubrey Sarvis, Executive Director of the Servicemembers Legal Defense Network, said that any law that pushed out qualified troops during wartime undermined military readiness and effectiveness.

"Gen. Conway was the only chief to say to Congress that the law is 'working'," Sarvis said. "It is not working."

problem," Blum states.

"The issue is to get the Senate Armed Services Committee to approve the Senate version and bring it to the floor of the Senate for a vote.

liest battles of World War II. Rosenthal's iconic image would come to serve as the model for one of the most recognized and visited monuments in the world.

President Dwight D. Eisenhower formally dedicated the 78-foot-tall Marine Corps War Memorial on Nov. 10, 1954. Rising from hallowed ground on Arlington Ridge overlooking the Potomac River at the entrance to Arlington National Cemetery, the Marine Corps War Memorial stands as a monument to not only those Marines who have made the ultimate sacrifice for their country, but as a tribute to all men who have cherished country above life. It is an enduring symbol of America's resolve and an icon for Marines, past and present.

The Marine Corps War Memorial is the largest bronze monument in the world; it is also one of the most renown. The original cost of creating the statue and devel-

oping the memorial site was borne entirely through private donation. Since its dedication, the National Park Service has maintained and administered the monument. The Marine Corps War Memorial Foundation, also known as "Iwo Flags," is comprised of a group of Marines that has vigilantly preserved and rotated the 10' by 19' flag that is flown above the monument, out of a continued sense of personal responsibility to those for whom the monument is dedicated. The Park Service is now encouraging us to expand our efforts in a joint venture with them to address growing deficiencies. Now 55 years old, the memorial needs annual museum grade cleaning, sealing and waxing. The black granite panels at the base require attention to prevent further loosening and shifting. The perimeter road needs to be milled and resurfaced. New perimeter and directional signs need to be emplaced and a new entrance sign befitting the dignity and decorum of the site are needed.

Finally, we need to provide comfort stations and a Ranger office with appropriate storage facilities to effectively support the growing number of memorial visitors and Sunset Parade attendees. These improvements will be costly. The Foundation is a non-profit 501 (c) 19 Veteran Organization, allowing it to receive tax deductible donations and sponsorships to help fund its efforts. Additionally, we are developing a ten year plan to achieve our goals. The plan will focus on three distinct elements: restoring and preserving the memorial and grounds; continuing the monthly flag rotation at the monument; and annually commemorating the Mount Suribachi flag-raising.

As Marines, each of us was entrusted with preserving the "eternal spirit" that General Lejeune so eloquently described as having "animated our Corps from generation to generation" and being "the distinguishing mark of the Marines in every age." In many cases we did so in the face of public apathy, a diminished sense of understanding by many of our elected officials who have never worn the uniform, and a fading memory of the achievements and sacrifices of generations of Americans from whom we who are Marines received our "high name of distinction and soldierly repute." We have done battle in the Beltway so that we could wage war against our nation's enemies.

Today, the Marine Corps War Memorial Foundation is skirmishing at the grass roots level to preserve the monument erected to the memory of those Americans who have made the ultimate sacrifice for their country. We feel it is a most worthy fight. So let us resolve together to "take increased devotion" and "preserve the eternal spirit which has animated our Corps from generation to generation."
