

THIEVES RAID GUAM WAR MEMORIAL

Brass panels containing the names of more than 6,000 Chamorros and U.S. service members who were tortured or killed during World War II were discovered stolen, pried off their concrete base at the Asan Bay Overlook on July 4.

Thieves stole 34 of the 99 panels at the overlook's memorial wall that honors all those who died during the Japanese occupation and the liberation of Guam almost 63 years to the day.

"These thieves did more than commit a despicable crime, they dishonored our people who suffered and died in the struggle for the freedoms we all enjoy today," acting Gov. Mike Cruz said yesterday.

"The memorial built for our people who suffered and lost their lives in the war is sacred and whoever stole those panels should be ashamed for desecrating the sacrifices our people made," Cruz said. 'No respect for the dead'

Tamuning resident Rose San Nicolas Manibusan said July 5 the incident has shocked her, and that seeing the magnitude of the damage was extremely painful.

A panel containing the names of many of her loved ones was among the 34 panels that were stolen.

"My grandmother's name was on one

of the panels that was stolen and she was one of the individuals who suffered from war atrocities," Manibusan said, adding that the entire "San Nicolas" panel was gone.

Manibusan also is the chief of interpretation for the National Park Service.

"It's just unbelievable that anyone would steal things that honor the war dead, and it's a shame that there are some individuals out there who have no respect for the dead," she said.

The Nimitz Hill site for the park unit, which was known as Fonte Plateau, was where Japanese forces set up defense barriers to try to stop the American forces

Japan Changes Name of Iwo Jima

TOKYO - Japan has changed the name of the Pacific island of Iwo Jima, site of the famous World War II battle, to its original name of **Iwo To** after residents there were prodded into action by two recent Clint Eastwood movies.

The new name in Japanese looks and means the same as Iwo Jima--or Sulfur Island--but sounds different, the Japanese Geographical Survey Institute said.

The institute announced the name change last month after discussing the issue with Japan's coast guard. An official map with the new name will be released Sept. 1.

Iwo Jima was the site of the World War II battle immortalized by the famous photograph by Joe Rosenthal of The Associated Press of U.S. Marines raising the American flag on the islet's Mount Suribachi.

Before the war, however, the volcanic island was known as Iwo To by the 1,000 or so civilians who lived there.




- 1) There are no longer Divisions at the State level, they will now be called Districts. The rationale for this is so there is no longer confusion between State and National, as National uses the term Division.

Heartbreaking

"This breaks my heart," said Superintendent M. Sarah Creachbaum, of the U.S. Interior Department's National Park Service.

"The memorial is a very important place for the people on the island to honor their ancestors who participated during the war."

"And most importantly, I think, to find comfort for the sacrifices that they and their ancestors made," Creachbaum added.

The theft comes at time when the island is preparing to commemorate the 63rd anniversary of Guam's liberation from Japanese occupation.

Dennis McMurray of Discover Guam, a local tour agency, was at the historic site yesterday with two off-island visitors.

"We have our Liberation Day coming up and these things are happening,' McMurray said.

"This is a shame and this is very sad for the people whose relatives' names were on the wall," he said.

the Pacific. Some Japanese navy officers who moved in to fortify the island mistakenly called it Iwo Jima, and the name stuck. After the war, civilians weren't allowed to return and the island was put to exclusive military use by both the U.S.

Never satisfied that the name Iwo Jima took root, locals took action in March after the release of Eastwood's two films "Letters from Iwo Jima" and "Flags of Our Fathers" spotlighted the misnomer.

"Though we're happy for Iwo To, which has been forgotten by history, the islanders are extremely grieved every time they hear Iwo To referred to as Iwo Jima," the local Ogasawara newspaper reported at the time.

Ogasawara, the municipality that administers Iwo To and neighboring islands, responded by adopting a resolution making Iwo To the official reading. Residents and descendants of Iwo To evacuees petitioned the central government to follow

"These people are now scattered nationwide and are not able to go back to Iwo To," said the survey institute's Mitsugu

"These people have said that the place is originally called Iwo To and their claim lead to this revision."

Today the only inhabitants are about 400 Japanese soldiers.

The 1945 battle for Iwo Jima pitted some 100,000 U.S. troops against 22,000 Japanese deeply dug into a labyrinth of tunnels and trenches. Nearly 7,000 Americans were killed capturing the island, and fewer than 1,000 of the Japanese would survive.

The Americans occupied the island after the war, and returned it to Japanese jurisdiction in 1968. The U.S. Navy still uses an Iwo To airstrip to train pilots who operate from aircraft carriers.



- * Miniature medals may be worn on the Blazer as part of the MCL Formal Uniform (tuxedo shirt, bow tie).
- * Large medals may be worn on the MCL Mess Jacket.
