## Bad 'Judge'ment: Stolen Valor Act 'Unconstitutional'

A law that makes it illegal to lie about being a war hero is unconstitutional because it violates free speech, a federal judge ruled July 16 as he dismissed a case against a Colorado man who claimed he received two military medals.

**Rick Glen Strandlof** claimed he was a former Marine who was wounded in Iraq and received the Purple Heart and Silver Star, but the military had no record he ever served. He was charged with violating the Stolen Valor Act, which makes it a crime punishable by up to a year in jail to falsely claim to have won a military medal.

**U.S. District Judge Robert Blackburn** dismissed the case and said the law is unconstitutional, ruling the government did not show it has a com-

elling reason to restrict that type of statement.

A spokesman for the U.S. attorney in Denver said prosecutors are reviewing the decision and haven't decided whether to appeal. The spokesman said that decision would be made by the U.S. Justice Department in Washington and prosecutors in Denver.

Strandlof's lawyer, **Bob Pepin**, said he hadn't spoken to Strandlof since the ruling was issued. Pepin said he would advise Strandlof not to comment publicly because the case might be appealed.

"Obviously, we think this is the right decision, or we wouldn't have been making the objections to the statute to begin with," he said. Pepin said Strandlof has been living in a halfway house in Den-

ver while his case is in the courts.

The law has also been challenged in California and in a case now before the 9th U.S. Circuit Court of Appeals.

Denver attorney **Christopher P. Beall**, who filed a friend-of-the-court brief for the American Civil Liberties Union of Colorado, said the Stolen Valor Act is fatally flawed because it doesn't require prosecutors to show anyone was harmed or defamed by the lie.

"The government position was that any speech that's false is not protected by the First Amendment. That proposition is very dangerous," Beall said.

"It puts the government in a much more powerful position to prosecute people for

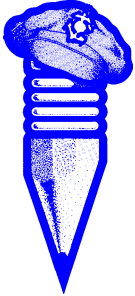

# M I N U T E S

The regular meeting of Central Bucks Detachment #636, Inc., of the Marine Corps League of Pennsylvania, Inc., was held July 14, 2010, at the Albert E. Atkinson American Legion Post, 315 North St., Doylestown, PA.

There were 18 members present including all officers except the Senior Vice Commandant. Distinguished members in attendance included **Past Commandants Don Gee, Don Parzaneze Sr., Budd Pearce, and Bob Sundling, Department of Pennsylvania Southeast Division Commandant/Junior Past Commandant Bill Miller, Past National Northeast Division Commandant/Past Department of New Jersey Commandant Ed Hoth.**

## Gen. Mattis Tapped to Head CENTCOM

WASHINGTON--**Marine Corps Gen. James Mattis** has been picked to take over U.S. Central Command, the Pentagon announced July 8.

Mattis would replace **Gen. David Petraeus**, who is now in Afghanistan as the U.S. and NATO's top military officer there.

The shake-up comes as the American public questions whether the fight in Afghanistan can be won, and the Defense Department is reeling from losing its top war commander--**Gen. Stanley McChrystal**.

As head of Central Command, Mattis would oversee U.S. military operations in Afghanistan and Pakistan, as well as across the Middle East, including Iraq and Iran.

**Defense Secretary Robert Gates** told reporters that he was impressed with the general's "strategic insight and independent thinking."

Mattis is a blunt-talking, seasoned war veteran best known for leading troops into the bloody battle of Fallujah in Iraq in 2004.

He is a bit of a surprising pick. On the one hand, Mattis has significant ground combat experience and is considered an intellectual who grasps the nuances of fighting a complicated counterinsurgency.

But he is also known to speak bluntly and off-the-cuff--much like Petraeus' predecessor Gen. McChrystal who was fired for speaking ill of his civilian bosses.

In 2005, Mattis was chastised by his superiors for saying in a public speech in San Diego that it was "fun to shoot some people." Mattis was a three-star general at the time, stationed in Quantico, VA, when he told an audience that some Afghans deserved to die.

"Actually, it's a lot of fun to fight," he said. "You know, it's a hell of a hoot. . . . It's fun to shoot some people. I'll be right up front with you. I like brawling."

He added, "You go into Afghanistan, you got guys who slap women around for five years because they didn't wear a veil. You know, guys like that ain't got no manhood left anyway. So it's a hell of a lot of fun to shoot them."

His comments evoked laughter and applause from the audience.

His boss at the time, **Gen. Mike Hagee**, said that the comments reflected the "unfortunate and harsh realities of war" but that Mattis had been asked to watch his words in public.

Gates said July 8 that appropriate action was taken at the time. He also said he raised the issue with Mattis when interviewing him for the job and was confident that such statements would not be made in the future.

"I think the subsequent five years have demonstrated that the lesson was learned," he said.

**Adm. Mike Mullen**, Chairman of the Joint Chiefs of Staff, said he has been impressed watching Mattis interact with

NATO allies, most recently as Mattis served as head of U.S. Joint Forces Command.

In 2004, Mattis' Marine division led the assault on Fallujah and he played a key role in helping Iraqi security forces negotiate with insurgents inside the city.

His remarks at the time of the battle suggest his thinking is very much in line with the counterinsurgency strategy pursued by Petraeus and McChrystal, which restricts military operations in order to win the support of the local population.

"All along we had intended a softer approach, using civil-military operations... unless someone chooses to fight, and then we would fight," Mattis said in 2004. "Welcome to war with all its complexities and shifting centers of gravity."

## Korean War Armistice Marked on Sat., July 24

Each year for the past 11 years, a Memorial Service has been held at the Korean War Memorial in Doylestown. The Memorial, which was dedicated by members of the Bucks County Chapter of the Korean War Veterans Association in 2000, was the first Korean Memorial in eastern Pennsylvania. It's located in the small memorial park in front of the Bucks County Courthouse.

The service is usually held on July 27, the anniversary of the day the war ended in Korea. July 27 has been designated "Korean War Armistice Day" by Presidents Clinton, Bush and Obama. This year, the ceremony will be held three days earlier, on Saturday, July 24.

This change of dates was to accommodate a group of 12 Korean dignitaries who are visiting Bucks County from Incheon, Korea, and who will be in attendance.

As the solemn part of the service begins, wreaths are laid at the base of the memorial by members of individual military and veterans organizations

This is followed by a "roll call of the dead," during which the names of the 38 young men from Bucks County who died in Korea are read, accompanied by the peeling of a large bell. Several of these men died at the Chosin Reservoir. As each name is called, a friend, family member, or another Korean War veteran places a

rose on the memorial. This is followed by a rifle salute (by a Marine Corps, or intra-service color guard and ceremonial rifle squad), taps, and a benediction.

For the past four years, the names of the 18 individuals from Bucks County who died in Iraq or Afghanistan have been read and members of their families attend and place a rose on the memorial.

A Korean-American children's choir, composed of boys and girls 4 to 10 years old will also participate, singing several Korean folk songs - including "Arrirang," a song familiar to most Korean War veterans.

Traditionally, the service has always included a special keynote speaker. This year's speaker is **LtGen. John F. Kelly**, USMC. LtGen. Kelly has already had two tours in Iraq, led the attack on Fallujah, and today has the largest command in the Marine Corps.

The memorial service is scheduled to begin at noon, and should last about one hour. Prior to this year's ceremony, there will be a military band concert by **The Old Comrades Concert Band** at 11 a.m.

The Bucks County courthouse is located at 55 E. Court Street in Doylestown. There is a large free parking lot across Main Street from the Courthouse that should be relatively empty on a Saturday morning.

speaking out on things they believe to be true but turn out not to be true," he said.

Beall said the ACLU was not defending the actions Strandlof is accused of, but took issue with the principle behind the law.

**Rep. John Salazar**, who sponsored the Stolen Valor Act in the House, predicted the decision will be overturned on appeal.

"This is an issue of fraud plain and simple," Salazar said in a written release. "The individuals who violate this law are those who knowingly portray themselves as pillars of the community for personal and monetary gain."

**Pam Sterner**, who as a college student wrote a policy analysis that became the basis of Salazar's bill, said the issue isn't free speech but misrepresentation. Sterner, a former Coloradan who now lives in Virginia, said authentic medal winners' credibility suffers when impostors are exposed because the public becomes suspicious of even true stories of heroism.
