# MINUTES

The regular meeting of Central Bucks Detachment #636, Inc., of the Marine Corps League of Pennsylvania, Inc., was held July 10th, 2013, at the Albert E. Atkinson American Legion Post, 315 North St., Doylestown, PA. There were 17 members and 1 guest present including all officers. Distinguished members in attendance included Past Commandants Bud Pearce, Jim Powell, Bob Sundling, Don Gee, and Don Parzanese Sr. Department of Pennsylvania Senior Vice Commandant Jim Powell and Detachment Marine of the Year Vince DeBella were also recognized.

The Minutes of the May Meeting as published in Listen Up! were adopted.

Sick and Distressed: Don Gee, PC reported that Jessica Clymer will be getting discharged from the Marine Corps due to medical issues. Jack Gentile reported that Marine Ken Murray had surgery on his leg as was recuperating. Bud Pearce, PC reported that Associate member Larry Sheetz was still having heart issues but was home and recuperating.

New Members: Wilfredo Acosta Jr. was voted on, accepted and given the Oath of Membership.

#### OFFICER REPORTS

Commandant Joe Kier reported on the 2013 Department Convention. He brought a Convention Book for everyone to look thru. He reported that member delinquency was an issue League wide. Our own Bill Miller was again elected as District One Vice Commandant and appointed Command-ant Kier as his Assistant. The trailer tire blowout on July 4th was discussed. He reported on the Detachment Staff Meeting held last week. Handed out literature on Marine Corps League awards and uniforms and discussed them with the body. 


