## CHARTER MEMBER BOB SCHAFFER SUCCUMBS TO CANCER

Detachment Charter Member **Robert A. "Bob" Schaffer**, 72, who won several Department of Pennsylvania 1st Place Awards as Editor of the "Listen Up!", died Jan. 7 at Doylestown Hospital after a courageous battle with cancer.

A Life Member of the Marine Corps League, he served as "Listen Up!" editor for nearly a decade, garnering several Department 1st Place (Category I) Awards. He had previously served as the Detachment's Senior Vice Commandant. He was solely responsible for the Detachment getting a number of business parking areas near Delaware Valley College for us to use as a fund-raiser during the school's annual "A-Day" celebration. It turned out to be the Detachment's biggest fund-raising activity.

Detachment **Commandant Budd Pearce** officiated at and Detachment members participated in a Marine Corps League ceremony as part of the memorial service at Doylestown Presbyterian Church on Sunday, Jan. 10.

Bob was a veteran of World War II and the Korean War, attaining the rank of Sergeant before being discharged.

Upon leaving active duty, Bob was employed in 1951 as a Construction Engineer with the Pennsylvania Department of Transportation. He retired from

Penn DOT in 1986 as a Civil Engineer and an Assistant District Construction Engineer. Additionally, in May 1968, he began serving as New Britain Borough Engineer and assumed the additional duties of Borough Manager in 1996.

For the past 41 years, Bob had walked the sidelines of more than 400 Central Bucks West football games as team statistician and was proud of the fact that he never missed a game until his illness forced him from the sidelines this past November, but he rebounded even though in his wheelchair for the playoff games. When the team won the State Championship on Dec. 12, the players presented the "game ball" autographed by every member of the program to him. Coach Pettine and virtually the entire team attended the Jan. 10 Memorial Service.

One of Bob's lasting contributions to the team was the team yearbook. With the help of **Fred Schote**, his spotter and right-hand man since 1973, and **Roger Conduit**, he lovingly put the now legendary book together at the end of each season.

Complete with individual and team statistics, photographs and newspaper clippings, "The Book" was presented to every person associated with the school's

## MARINES REPEL SYRIAN MOB

Marine security forces assigned to the U.S. Embassy in Damascus, Syria, used riot-control gas to disperse an angry mob Dec. 19 after an anti-American protest there turned violent.

State Department officials said rioters forced their way into the embassy compound and threw rocks and bottles at the Marines. Some protesters scaled a wall at the embassy and ripped down the American flag.

Once the rioters were driven from the embassy area, the group attacked the ambassador's residence, causing extensive damage, according to Andy Laine, a Bureau of Diplomatic Security spokesman. He was unsure whether the Marines responded to that incident as well, but said a Syrian police force arrived to help restore order.

## KOREAN WAR VETS FOUNDATION FORMED

In preparation for the 50th anniversary commemoration of the Korean War, veterans of that conflict are being encouraged to register with the U.S. Korea 2000 Foundation, Inc.

According to Department of Veterans Affairs (VA) statistics, less than 20 percent of Korean War veterans belong to a national veterans organizations. The Foundation wants to locate the remaining 80 percent and notify them of the national and international events that will mark the anniversary.

## **Army Managing DoD 'Cold War Certificate' Program**

The Army is managing a Department of Defense program that recognizes service members and government civilian employees for their service during the Cold War.

Qualified military and civilian personnel can now access the Internet address <http://sdcw.army.mil/coldwar> to obtain information on how to receive a Cold War Recognition Certificate signed by **Secretary of Defense William S. Cohen**, according to **Army Major Dan Gibson**, Chief of Military Awards Branch, The Adjutant General Directorate.

"The Internet address will provide applicants with information on how to apply for the Cold War Certificate," Gibson said. "**Applications will appear on the website April 5.** The applications will collect individual/personal data and instruct applicants on which documentation will be needed," he stated.

Gibson cautions applicants not to send original required documents, such as DD Forms 214 (Certificate of Release/Discharge from Military Service). Photocopies only should be forwarded, he added, as any documents sent will not be returned.

The Department of the Army is designated as the executive agent for implementation and award of the CWRC. The Personnel Service Support Division, The Adjutant General Directorate, U.S. Total Army Personnel Command, Alexandria, VA, is responsible for the program.

The Certificate will be provided to all members of the Armed Forces and qualified Federal government employees who faithfully served the United States during the Cold War era, from Sept. 2, 1945, to Dec. 26, 1991, according to officials. Cohen approved issuance of the certificate in accordance with Section 1084 of the 1998 National Defense Authorization Act.

Above Cohen's signature, the Certificate bears the inscription: "In recognition of your service during the period of the Cold War (2 September 1945 - 16 December 1991) in promoting peace and stability for this Nation, the people of this Nation are forever grateful"

At the end of World War II in 1945, the United States and the Soviet Union, formerly allies, became rivals for political and military influence throughout the world. The struggle erupted in several flash points over the years, to include the Korean War (1950-53), the Hungarian Revolution (1956), the Berlin Crisis (1961), the Cuban Missile Crisis (1962), and the Vietnam Conflict (1964-1975).

## Marine Corps Heritage Foundation Formed; Seeking Funds for Center at Quantico

QUANTICO, VA--Now that the U.S. Marine Corps has announced plans to consider creation of a Marine Corps Heritage Center that would be located at Marine Corps Base, Quantico, VA, the recently renamed Marine Corps Heritage Foundation (formerly the Marine Corps Historical Foundation) is launching plans to assist with this long-term project.

The Foundation is exploring potential sources of private funds for a portion of the funding for the Center.

Although plans are still in the study phase, those involved with planning for the Center, including members of the Marine Corps Heritage Foundation, indicate it has the potential to be a major regional attraction for visitors, scholars, historians, and students. Located adjacent to Interstate 95 and U.S. Route 1, the Center would be a showplace for highlighting the Marine Corps' varied capabilities before numerous diverse and distinguished guests.

Located at what Marines call the "Crossroads of the Marine Corps," it is expected to attract and educate visitors from throughout the United States and around the world.

**General Charles C. Krulak**, Commandant of the Marine Corps, has said "The Marine Corps Heritage Center is envisioned as a multi-use complex of buildings and outdoor facilities. It will be devoted to the presentation of Marine Corps history, professional military educational opportunities and unique military events. This complex, with its varied capabilities, will be the showcase of our Marine Corps heritage: its glorious past, present and future."

Established in 1979, the Marine Corps

when we began operations, was to honor all individuals who have or are now training the future of our Corps.

Since then, we have been working on a monument to be placed at each Recruit Depot to do just that. This has been a long and enduring project; at last we can see the end. It is our hope that both monuments will be in place and dedi-

Heritage Foundation is a non-profit [501(c)(3)] organization dedicated to the preservation and protection of Marine Corps history and traditions. It directly supports the historical programs of the Marine Corps in ways that otherwise might not be available through government funding.

In announcing its recent name change, **LtGen. Philip D. ## Marine Swaps Blues for Whites

The Marine Corps' recently retired Head of Logistics may not wear his Dress Blues anymore, but he's still in uniform.

Retired **Major General Joseph Stewart**, formerly the Deputy Chief of Staff for Installations and Logistics, became the 9th Superintendent of the U. S. Merchant Marine Academy recently, according to an Academy news release.

Stewart, a 1964 graduate of the U.S. Naval Academy, accepted a commission as a Rear Admiral in the U. S. Maritime Service as part of his appoint-

ment as Superintendent, according to Academy officials.

He relieved **RAdm. Thomas T. Matteson**, a former Coast Guard flag officer.

The Merchant Marine Academy is a federal academy with about 950 midshipmen trained for careers aboard U. S. merchant ships, ashore in the transportation industry and as officers in the Armed Forces. Stewart holds master degrees in operations research and management from the Naval Postgraduate School and Salve Regina College.

# MAJORS PUNISHED FOR SPEAKING OUT

In the midst of the Clinton investigation and ensuing impeachment proceedings, two Marine Corps field-grade officers were reprimanded for their criticism of their commander-in-chief.

Major Shane Sellers was the first to discuss Clinton's actions in print. His

Oct. 19 opinion piece in *Navy Times* prompted a Marine Corps inquiry to determine whether he violated Article 88 of the Uniform Code of Military Justice, which prohibits uniformed officers from speaking "contemptuously" of the President.

His commentary drew national media attention and raised the ire of many service members, who felt an officer had no place criticizing the commander-in-chief.

Many others, however, voiced their support of Sellers' stance.

The Corps took no punitive action

against Sellers and instead opted to handle the matter through administrative action, essentially a verbal scolding.

Sellers' reserve counterpart, Major Daniel Rabil, wasn't so lucky.

Rabil was administratively punished the week of Dec. 7 for his criticism of Clinton, which appeared in the Nov. 9 issue of *The Washington Times*.

He was not charged with violating Article 88, but an "official counseling letter" was placed in Rabil's record and he was involuntarily transferred to the Individual Ready Reserve.

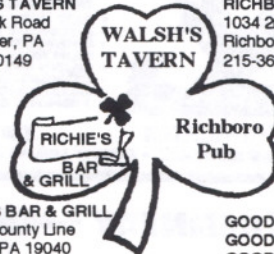
