OFFICER REPORTS

Commandant Don Gee reported he attended an Eagle Scout Court of Honor and presented Marine Corps League Eagle Scout Certificates to five new Eagle Scouts from Troop 230 of Yardley, PA.

Senior Vice Bud Pearce, **PC** reported the Detachment strength at 88 members including 73 Regular Members of which 22 are Life Members and two are Dual Members; and 15 Associate Members of which one is a Life Member. There are 19 members delinquent in their dues.

Junior Vice Commandant Bill McBride reported:

- * The Detachment Fund Raiser at the Doylestown/Cross Keys State Store was the most successful we've ever had. He thanked those Detachment members who participated in the fund raiser.
- * He reported the Department Raffle tickets sales have concluded.
- * He also reported he had contacted Gen. Ron Nelson about being the Guest of Honor for the Birthday Ball. Since he did not receive any reply, Bucks County Veterans Affairs Director Dan Fraley has been asked to be the Guest of Honor and he has accepted. A formal invitation will be sent to him. Sgt. Grit will provide a K-Bar and case at no cost as a gift for the Guest of Honor.

Paymaster Jim Powell, DC presented the Paymaster's financial report and it was adopted

Adjutant Joe Kier, PC was excused and the Paymaster reported the following correspondence:

- * A communication from the Department stating Detachments are now being encouraged to appoint a Service Officer to assist members seeking Veterans assistance.
- * A notice from a non-profit organization which provides dogs to Veterans with PTSD and related ailments and injuries is seeking the names of Veterans in need of their services. They apparently pair Veterans with dogs to help with both the training of the dogs and the therapy for the Veterans.
- * The Lancaster Detachment which because of changing games of chance laws, recommends obtaining donated funds from non-profit organizations which have bars, etc. The Toys for Tots Coordinator at the Detachment sent out a letter to entities which were covered by the laws explaining the different programs which the Detachment supported and that the Detachment would be happy to receive the funds they are now required to disburse to charities. The Paymaster recommended our Detachment consider a similar effort. The Lancaster Detachment raised more than \$3,000 from the mail out.
- * He also reported on the upcoming Department Golf Tournament. Various levels of sponsorship are being sought. Participants are also being sought. Former Commandant of the Marine Corps Gen. James Conway is the special guest for the event.

- * A letter was received from the County Recorder of Deeds concerning "Honor Flight Bucks County" for WWII and Korea Veterans which was held in September 2014. A second Honor Flight is scheduled for October 15. He is looking for organizations to take a 1/4-page ad for \$550 in the October Veteran ID Card Directory to help underwrite the flight.
- * A Job Fair is being held at Ft. Indiantown Gap on June 25.
- * The "Sergeant Mac Foundation" is trying to raise \$8,000 for its wreath program. Last year they obtained 9,000 wreaths. This year they want to acquire 10,000.

Judge Advocate Tom Spoltore was excused, no report.

Chaplain Sam DiValentino reported he had sent a card to Marine Don Warner and further requested that he be informed about any member or member's family member in need of his services. Paymaster Powell noted that two of our deceased members are still being carried on the roster promulgated by Marine Corps League Headquarters. He asked if the Chaplain or anyone else had any MCL Death Certificates with which we could report the deaths. No one had any on hand.

Sergeant-at-Arms Bob Sundling, PC reported he was seeking Color Guard members for the 4th of July Parade in Chalfont. He also thanked Marines Bobby Sundling, Sam DiValentino and Don Parzanese Jr for participating in the Memorial Day Parade Color Guard. **Quartermaster Corey Fisher** had nothing to report.

Junior Past Commandant Kier was excused, no report.

Public Relations/Newsletter Editor Alex Kier was excused and Commandant Gee announced that June 20th is the cutoff for anything that is requested to be put into the next newsletter.
