## MONTHLY DETACHMENT MEETING



The regular meeting of Central Bucks Detachment #636, Inc., of the Marine Corps League of Pennsylvania, Inc., was held May 8th, 2013, at the Albert E. Atkinson American Legion Post, 315 North St., Doylestown, PA. There were 14 members and 3 guests present including all officers except Commandant Joe Kier who was excused. Distinguished members in attendance included Past Commandants Bud Pearce, Bob Sundling, Don Gee, Don Parzanese Sr. and Department of Pennsylvania Junior Vice Commandant and Past Detachment Commandant Jim Powell. Detachment Marine of the Year Vince DeBella was recognized.

The Minutes of the April Meeting as published in Listen Up! were adopted.

**Sick and Distressed: Bob Sundling, PC** reported that his son and Detachment member Bobby Sundling sustained a severe cut on his eye while grinding a tree stump and they are not sure if his vision will be permanently affected. He is still recuperating at this time. **Bud Pearce, PC** reported that Associate member Larry Sheetz had a procedure to add another stint to his heart.

New Members: Marion Konopitski and Patrick Glozzer were voted on, accepted and give the Oath of Membership.

#### **OFFICER REPORTS**

Commandant's Report – Senior Vice Jack Gentile filling in the Commandant Kier reported on the progress of the Trailer repair. Pictures of the trailer were passed around for everyone to view. He also reported that we have been asked to attend a Memorial Service will be held on May 11, 2013 at First Baptist Church, Lansdale, for Marine Alphonse "Chuck" Craig. His brother in law is a MCL member in NJ and asked for our help. 
