# A Lasting Legacy for Vietnam Veterans

2012 is an important year for Vietnam War veterans and their families. This is the year that the Vietnam Veterans Memorial Fund (VVMF) will break ground to build an Education Center at The Wall designed to connect future visitors with the 58,272 names of the MIA/KIA's on the Vietnam Wall. The Education Center, to be constructed across the street from the Vietnam Veterans Memorial, will contain photos and personal stories about those whose names are on The Wall. Congress has given the project its approval.

For the last few years, VVMF has conducted a campaign to collect photos of all the 58,000 + names on the wall and to raise private contributions to pay for the over \$85 million in projected costs. To assist VVMF staff with these efforts,VVMF founder and president **Jan C. Scruggs** has formed a National Campaign Committee with Honorary Chairman **General Colin Powell**, USA (Ret.), Advisory Board Chairman **General Barry R. McCaffrey**, USA (Ret.) and National Spokesman actor **Tom Selleck**.

Both of these tasks, the collection of 58,000+ photos and the raising of \$85+ million, are daunting. However, Scruggs faced and overcame an even more daunting challenge when he initially conceived the idea for The Wall in 1979, which he dedicated in 1982.

There are two important ways that supporters, many Vietnam Veterans, their families and their close friends, can assist Scruggs and VVMF. The first is with the photos.

First, the photos. The first step is to visit the website **www.vvmf.org/thewall** and search for your casualty by name. Once you find the right person, click on "profile" to see if there is a photo posted. If not, then you can add one as well as post a remem-

brance.

The easiest way to send a photo is as an email attachment scanned at 300 dpi or higher. If you cannot locate a quality studio portrait, preferably one in uniform, try to scan one from a high school or college yearbook, a group photo, or even a snapshot.

If you cannot produce a photo to send as an email attachment, a copy of a photo (VVMF does not want original photos and cannot be responsible for returning photos) can be sent to: Vietnam Veterans Memorial Fund; ATTN: Call for Photos;

Post, and Vietnam Veterans of America Chapter. The UVD is responsible for conducting the annual Doylestown Memorial Day Parade. Now in its 146th year, it is the oldest such parade in Pennsylvania. The Detachment is also the lead unit in the annual 4th of July Parade in Chalfont, PA.

The Detachment sponsors the Liberty Young Marines Unit and is actively involved in conducting the annual "Toys for Tots" program in its area.

Central Bucks Detachment members have served on committees and had major roles in the funding for and construction of the Bucks County World War II Monument (at the Bucks County Courthouse) and the Doylestown Community Service & Veterans Monument (on Rt. 611 at the southern entrance to Doylestown).

The Detachment continues its service to the League and the Central Bucks community.

#### VA Urges Vets Exposed to Agent Orange Be Screened for Prostate Cancer

"Veterans exposed to Agent Orange are at least twice as likely to develop prostate cancer; their recurrence rates are higher; and recurring cancers are more aggressive," noted **Dr. Thomas Berger**, Executive Director of VVA's Veterans Health Council, before today's Congressional Men's Health Caucus Prostate Cancer Task Force. Berger urged his fellow Vietnam veterans to get screened, noting "it's worth the fight."

Said Berger, "Some three m illion veterans served in Southeast Asia, and no one knows for sure how m any of these veterans were exposed to Agent Orange." In

1996 the Institute of Medicine of the National Academy of Sciences concluded there is "limited evidence of a positive association between prostate cancer and exposure to herbicides used in Vietnam , including Agent Orange." As a result of IOM's findings, Jesse Brown, then-Secretary of the Veterans Administration (VA), issued the final rule, recognizing prostate cancer as a service-connected, presumptive disease associated with exposure to Agent Orange and other phenoxy herbicides during military service, allowing such exposed veterans to become eligible for VA disability compensation and health care.

In 2008, University of California-Davis Cancer Center physicians released results of research showing Vietnam veterans exposed to Agent Orange have greatly increased risks of prostate cancer and even greater risks of getting the most aggressive form of the disease as compared to those who were not exposed. The research was also the first to use a large population of men in their 60s and the prostate-specific antigen (PSA) test. More than 13,000 Vietnam veterans enrolled in the VA Northern California Health Care System were stratified into two groups, exposed or not exposed to Agent Orange between

1962 and 1971. Based on medical evaluations conducted between 1998 and 2006, the study revealed that:

§ twice as many Agent Orange-exposed men were identified with prostate cancer than non-exposed;

§ Agent Orange-exposed men were diagnosed two-and-a-half years younger than non-exposed; and § Agent Orange-exposed men were nearly four times more likely to present with metastatic disease than non-exposed.

Further buttressing this link, in 2009, a study of 1,495 veterans in five cities who underwent radical prostatectomy to remove their cancerous prostates showed 206 exposed to Agent Orange had a near 50 percent increased risk of their cancer recurring, despite the can-
