

## **NEW HELMET CONTRACT AWARDED**

The Marine Corps and Army have tapped Ceradyne Inc., to make the first of the new Enhanced Combat Helmets, ending a five-year search for a brain bucket capable of stopping rifle rounds.

The Marines and Army have given the green light to Ceradyne to build 8,600 ECHs, which will be split between the services. Fielding won't begin until after the services approve the ECH for fullrate production, a decision scheduled for May.



The ECH is a protective helmet consisting of a ballistic protective shell, pad suspension system and four-point chinstrap/nape strap retention system. This helmet fully exploits the latest lightweight material technology, Ultra-High Molecular Weight Polyethylene materials, to provide increased small arms protection above what is currently provided by the Marine Corps Lightweight Helmet (LWH) and the Army Advanced Combat Helmet (ACH). This material provides a higher degree of ballistic protection than Kevlar and Twaron, fibers used in both the LWH and ACH. It also provides enhanced protection against fragments.

In 2007, the Army and Marine Corps began looking into how to make current helmets stronger without increasing weight. Both could withstand a direct hit from a 9mm pistol round and some bomb fragments, but senior officials in both services wanted improved protection against rifle shots.

The contract award comes after the Ceradyne ECH suffered failures in the First Article Test process early last year. I guess we'll have to trust that the problems were resolved. The Marines are expected to receive 38,500 helmets, while the Army will buy a total of 200,000

### Women to Attend Infantry School at Quantico

The Marine Corps school that produces infantry combat officers will enroll its first-ever female students this year, *Marine Corps Times* has learned.

As part of the service's extensive research campaign to determine what additional jobs could be opened to women, an undetermined number of volunteers will attend the Infantry Officers Course in Quantico, VA, said **Gen. Joseph Dunford**, the Corps' Assistant Commandant. There, Marine officers are groomed to serve in direct combat roles and lead troops into battle.

"We are in the process right now of soliciting volunteers," Dunford said on Apr. 18.

It's a monumental--if controversial-move for the Marine Corps, which until now barred female Marines from the program and required instead that they attend other courses aimed at preparing them for assignments in support roles such as logistics, personnel administration and aircraft maintenance, among others.

Soon, enlisted women also will have an opportunity to attend infantry training, Dunford said.

Marine officials are developing plans to assign female Marines to the Corps' Infantry Training Battalions, which fall

## LASTING LEGACY FOR VIETNAM VETERANS

2012 is an important year for Vietnam War veterans and their families.

This is the year that the Vietnam Veterans Memorial Fund (VVMF) will break ground to build an Education Center at The Wall designed to connect future visitors with the 58,272 names of the MIA/KIA's on the Vietnam Wall. The Education Center, to be constructed across the street from the Vietnam Veterans Memorial, will contain photos and personal stories about those whose names are on The Wall. Congress has given the project its approval.

For the last few years, VVMF has conducted a campaign to collect photos of all the 58,000 + names on the wall and to raise private contributions to pay for the over \$85 million in projected costs. To assist VVMF staff with these efforts, VVMF founder and President Jan C. Scruggs has formed a National Campaign Committee with Honorary Chairman Gen. Colin Powell, USA (Ret.), Advisory Board Chairman Gen. Barry R. McCaffrey, USA (Ret.) and National Spokesman actor (and Vietnam era veteran) Tom Selleck.

Both of these tasks, the collection of 58,000 + photos and the raising of \$85+ million, are daunting. However, Scruggs faced and overcame an even more daunting challenge when he initially conceived the idea for The Wall in 1979, which he dedicated in 1982. Since then, The Wall has been one of the most visited sites on the National Mall. There are two important ways that supporters, many Vietnam Veterans, their families and their close friends, can assist Scruggs and VVMF. The first is with the photos and the second is with contributions toward the financing of the project.

First, the photos. The first step is to visit the website **www.vvmf.org/thewall** and search for your casualty by name. Once you find the right person, click on "profile" to see if there is a photo posted. If not, then you can add one as well as post a remembrance.

The easiest way to send a photo is as an email attachment scanned at 300 dpi or higher. If you cannot locate a quality studio portrait, preferably one in uniform, try to scan one from a high school or college yearbook, a group photo, or even a snapshot. If you cannot produce a photo to send as an email attachment, a copy of a photo (VVMF does not want original photos and cannot be responsible for returning photos) can be sent to:

Next, the donation. VVMF has

scheduled the initial construction of the Education Center to begin with a ground breaking ceremony this year on Veterans Day, Nov. 11. This makes it imperative that VVMF and the Committee for the Education Center Project insure that sufficient funds have been collected to pay the initial costs before this year's Veterans Day. Time is of the essence.

To complete this challenge, Scruggs and his team have set a goal raising a gift of \$1,000 for each individual name on The Wall. Among the grassroots organizations that have stepped up to provide the \$1,000 for their individual members whose names are on The Wall is the West Point Class of 1953, a class that lost 13 of their members in the conflict. They began their effort when one member of the class took it upon himself to collect and submit 13 pictures of classmates. Then, they decided to raise the \$13,000 from the surviving members of the class. It took just under two weeks to raise that amount and when they ended their campaign, they had almost exceeded their goal by another \$13.000.

The last American combat unit left South Vietnam in 1973 and today the majority of the surviving veterans are in their sixties and seventies and are passing on each day at an accelerating rate. For most of them, this campaign to build the Education Center may be the last chance they will have to be a part of leaving a legacy for our nation's future citizens to understand the Vietnam War and the sacrifice of those whose names are on The Wall and the patriotism of those who fought and returned home.

dress:

under the Schools of the Infantry.

Officials don't yet know how many women--officer or enlisted--will be put into the academic pipeline for the Corps' "03" infantry occupational code, Dunford said. All will be volunteers--and it remains to be seen how many will answer the call, he said.

The Marine Corps' top General, **Commandant Gen. Jim Amos**, traveled Apr.18 to Camp Lejeune, NC, where among other business he was expected to meet with Marines and explain the service's plans for expanding women's career opportunities, Dunford said. Amos was joined by his senior enlisted adviser, **SgtMaj. Mike Barrett**.

"I think the important thing for us is to articulate the Commandant's intent, and to explain what he is doing and why he is doing it," Dunford said. "The best way to do that is face-to-face, and he, with the Sergeant Major ... is doing that right now."

The Corps has been studying this issue for more than a year. In February, officials announced that company-grade officers and staff noncommissioned officers would be assigned for the first time to select jobs previously open only to men, though not in the infantry or any billets for which ground combat is a primary mission.

Starting in May, women will be considered for about 400 positions within six types of battalions: Amphibious assault, Artillery, Combat assault, Combat engineer, Low-altitude air defense, Tank.

Additionally, new functional fitness tests are being developed to help Marine Corps leaders determine how women and men perform in, and cope with, various combat tasks. The goal is to establish "gender-neutral" physical fitness standards. Details are scant, but the Marine Corps' Training and Education Command is looking to purchase a variety of new equipment specifically for these tests, suggesting the tasks associated with them will closely mimic combatessential duties such as operating and moving heavy weaponry, and carrying casualties from the battlefield.

The Marine Corps defines gender-neutral physical standards as being identical for men and women, rather than weighted--or "gender-normed"--like those applied in the service's annual Physical Fitness Test. During the PFT, women can earn a minimum or maximum score with fewer repetitions and a slower run times than their male counterwould like to honor their Vietnam fallen, may want to follow the example of West Point Class of 1953.

This suggests that women wanting to serve in ground combat units will be given the shot to do so only if they can keep pace with their male counterparts. Standards would likely evaluate Marines not as women and men, but simply as infantrymen, tank crewmen or artillerymen, for example.

"There is a plan to ... evaluate males and females against those standards and, potentially, a downstream plan to put women through other training that actually will be informed by our experience" with infantry training, Dunford said. "I think you will hear more from the commandant on that coming up."

The data gleaned from all these efforts, Dunford said, will be used to inform a recommendation from the Marine Corps to **Defense Secretary Leon Panetta**.

This past winter, the Defense Department published a report saying that nonlinear combat against a shadowy enemy in Iraq and Afghanistan has negated the notion of a frontline behind which women can be kept safe.



## ALERT: NEW E-MAIL SCAM

### Beware--scam emails--that appear to be sent by DFAS employees!

There are emails being sent to individuals, including military members, military retirees, and civilian employees, which appear to be sent by a DFAS employee. Although the email appears to come from a DFAS employee and displays a dot mil address it is actually from a non-government email account. This is an example of what's called "spoofing."

The emails indicate that individuals who are receiving disability compensation from the Department of Veterans Affairs (VA) may be able to obtain additional funds from the Internal Revenue Service (IRS). These emails are not issued by DFAS and will likely result in a financial loss if you comply with the suggestions in the email. Bottom line--do not send your personal information or copies of your tax returns and 1099s to the individual listed in the email.

The email indicates that individuals receiving VA disability compensation can receive additional funds from the IRS. The email states that such funds can be obtained by sending copies of your VA award letter, your income tax returns, your 1099-Rs, your RAS statements, and a copy of your DD 214. to a so-called retired Colonel at an address in Florida. Do NOT follow the suggestions in the email because you will be providing a significant amount of your personal information to a complete stranger, which could result in a financial loss to you.

The 1099-Rs that are issued by DFAS reflect only the taxable portion of a member's retired pay. DFAS is not aware of any legal basis for the alleged additional funds that the IRS would supposedly pay over. By ignoring the email, you will avoid frustration, the release of personal information to a stranger, and the possibility of financial loss by ignoring the email. If you have any questions or concerns about these or any other tax issues, you should contact a known, reputable tax consultant, tax attorney, or legal assistance officer for advice and assistance. ### Japan, Marines Commemorate Battle of Iwo Jima

The Battle of Iwo Jima took place during February and March of 1945 in the midst of the Pacific

campaign of World War II. Both the U.S. and Japan suffered great losses during this battle.

The Iwo Jima commemoration ceremony is not only a time for reflection, but also an opportunity for the United States and Japan to honor the brave men who fought on this island 67 years ago. They truly represented the best of both nations.



#### MEMORANDUM FOR NATIONAL BOARD OF TRUSTEES DEPARTMENT COMMANDANTS DETACHMENT COMMANDANTS ALL MCL MEMBERS

#### Subj: MARINE CORPS LEAGUE POLICY ON POLITICAL PARTICIPATION IN LOCAL, STATE, AND NATIONAL ELECTIONS

Marines: As the 2012 political campaigns heat up this Spring and Summer in anticipation of the General elections in the Fall, I wanted to take a moment to remind you that, as a matter of League policy, Marine Corps League members wearing any part of the League uniform or identifying themselves as members of the Marine Corps League, cannot sponsor a political club; participate in any TV or radio program, or group discussion that advocates for or against a political party, candidate or cause; give interviews to the press or speak at any event promoting a political candidate or movement.

The following is the Marine Corps League's official <u>POLICY</u> on the aforementioned subject taken from the National Bylaws and Administrative Procedures, Chapter One, Section 110:

#### SECTION 110 - POLICY

(b) The Marine Corps League shall never take part in any labor or management dispute or issue, and it shall be ever non-sectarian, non-political, and non-partisan; nor shall it be based on the grounds of race, color, creed, nationality, or sex; nor shall it be used as a medium of political ambition or preferment; nor shall former or present military rank or former or present civilian position be used as the basis for special consideration or preferment.
