April 14, 2015

I traveled to Andy's Diner, home to 1210AM radio in Conshohocken, Pa to meet four Medal of Honor recipients. Approximately at 9:30am a white SUV with Police escort arrived. The first occupant to debark was Marine Hershel W. Williams, wearing Marine Corps League uniform with the unmistakable MOH Medal around his neck. Very agile and jovial along with the other MOH recipients, they posed for pictures outside the diner. Since I was in uniform as well, I caught his eye and he gave me a thumbs up and said , "Semper Fi Marine".

Marine Williams has the distinction of being the last living MOH recipient from the WW2 battle for Iwo Jima in Feb/Mar, 1945. The other MOH recipients were from the Vietnam era. They were Col. Barney Barnum, USMC, Michael E. Thorton, USN Seal, and Brian Thacker, USA. All of these heroes were patient, gracious and very inviting; signing autographs and having pictures taken with the crowd.

A once in a lifetime thrill to be "up close and personal" with men who made history.
