PRE- MEMORIAL DAY CEREMONIES

Any member who can attend the Religious Services on SUNDAY, May 27th, 10:30 A.M. at the Salem United Church of Christ, 168 East Court Street, Doylestown is encouraged to do so. This service is for all veterans organizations in Doylestown and is all denominational.

I would appreciate attendance. I will not personally be able to attend due to previous committments at my own church from 10:00 - 1:00.

Uniforms are not required, but you may wear your cover if you have one available. We were invited by the American Legion. From what I understand, there will be other Veterans groups in attendance as well.

MEMORIAL DAY CEREMONIES

8:30 A.M. - Flag Raising at CourtHouse
9:00 A.M. - Flag Ceremony at War Memorial Field
10:00 A.M. - PARADE GETS UNDERWAY

As you know, our Detachment will be having a float in the parade and we will be having 10 Marine Corps Period Uniforms worn by members of the Detachment and also Marines form the U.S. Marine Corps Recruiting Service in Doylestown, not Recruiters, but Poolees, these are young men in High School who are in the Delayed Entry Program (DEP). MSgt Conway assumed the responsibility of obtaining these poolees and has made arrangements to have the young men at his office on N. Main Street, Doylestown, at 0800 Hrs, May 28th for proper fitting, etc.. We will meet at the Recruiting Office for those of us who are a size 40 Regular to be donned with one of the period uniforms. Better to have more than not enough.

All other members of the Detachment should report to the same location as last year by 9:30 A.M. This is where the float will be. We will form and start on the street next to the Central Bucks West H.S. We will get underway at 10:00 A.M. (side street behind Herb"s Hobby Shop)

The times and events noted above, referring to the CourtHouse and War Memorial Field ceremonies are for information purposes only.

The Detachment will not be directly participating in these events. After the parade, those wearing the Period Uniforms will return to the Recruiting Office and change. Mike Waldron is responsible for the return and safekeeping of the uniforms that are on loan to us from Quantico Museum.

It would be best to have your spouse drop you off at either the Recruiting Office or the High School and then park near the end of the parade, either at the Legion or near my house on Belmont Avenue.

Note: Court Street will be closed as this is the parade route.


LAST REMINDERS!
