## Guadalcanal revisited

To the Editor:

I just returned from visiting Guadalcanal on the occasion of the 50th anniversary of the landing in World War II, and the dedication of the American and Allied memorials commemorating that event.

I want to thank you very much for your articles on the Guadalcanal landing and about some who participated in the landings and subsequent battles. It was a period where the combatants who fought knew very little about the other side. My own knowledge of the Japanese (I was 17 at the time) came mostly from comic books. Articles such as yours help fill in the gaps in understanding.

My trip left me with a number of impressions that I would like to share

with you:

"The people of this newly independent nation, Solomon Islands. British Commonwealth, S.I.B.C., were very friendly to their Allied liberators but are caught between these feelings for us and what is best for their current economy, like their participation in the "Greater East Asia Co-prosperity Sphere," which is alive and well on Guadalcanal.

In our hotel, Kitano Mendana, we awakened to three flags flying at equal level: Japanese, Solomon, Mendana Hotel. A delegation of Marine Corps veterans, without comment, lowered and removed the Japanese flag, and it

was not raised again until after we departed.

The visible press — camcorder, reporters and translators, and interviewers — came from Tokyo. Some representatives of the U.S. chains were present, but not visible and not very active. A crew from National Geographic was present, but I think they've been dealing with other people for so long they've forgotten how to relate to their peers. They required, even demanded, special treatment and adherence to their schedules wherever they went. The Tokyo Press worked hard and foliolowed us everywhere.

Our group ranged in age from 11 (the grandchild of a Guadalcanal veteran in our group) to 91 (a retired colonel who kept pace, in spite of the heat), and all decades between were represented. There were husbands and wives, some in their 70s and 80s; there were widows and sons and nephews of those killed in battle; there were histo-

ry and military buffs.

We all — veterans, relatives and history buffs — came away with a deeper understanding and appreciation of what happened 50 years ago. We also recognized the accomplishments, the problems and the potential of the emerging South Pacific island nations.

The following House and Senate bills were acted upon by the General Assembly, and in two instances, signed into law by the Governor. These include:

- 1. <u>Senate Bill 222</u> (sponsored by Senator Shumaker) Designates the fountain in the plaza of the East Wing of the Main Capitol Building as the "War Veterans Memorial Fountain." Requires the Department of General Services to erect an appropriate monument to depict this designation. This bill received final passage in the Senate on April 2, 1991, and is currently on the House calendar.
- 2. Senate Bill 868 (cosponsored by Senator Shumaker) Removes the criterion that a "paralyzed veteran," in order to be eligible for the paralyzed veterans pension, have served during an established war or armed conflict. This bill received final passage in the Senate on June 9, 1992, and is currently under review by the House Military and Veterans Affairs Committee.
- 3. Senate Bill 1572 Provides a bonus of \$100.00 per month served to veterans who had active service in the Persian Gulf Conflict Theater or to members of the Pennsylvania National Guard or reserve components who had active service in support of operations in the Persian Gulf Conflict Theater. Compensation may not exceed \$3,000. Also, provides for compensation of \$4,000 to families of deceased veterans and to prisoners-of-war. Authorizes the issuance of bonds, contingent upon voter approval, to fund the bonus program. Finally, would appropriate up to \$1,500,000 to fund a memorial at Fort Indiantown Gap National Cemetery for all Pennsylvania veterans. This bill received final passage in the Senate on June 8, 1992, and is currently under review by the House Military and Veterans Affairs Committee.
- 4. House Bill 211 Provides for the issuance of special registration plates for veterans of the Korean War. NOTE: Amended to include special registration plates for veterans of the Persian Gulf War. This bill received final passage in the Senate on June 30, 1992, and is now awaiting the concurrence of the House.
- National Guard or members of other reserve components who are called to active duty may: 1) terminate leases that were entered into prior to activation for active duty; 2) terminate or suspend memberships within health clubs, fitness centers, country clubs, etc. Also, sets a maximum interest rate of six percent for those obligations that were incurred prior to being called to active duty unless in the opinion of the court the individual is not materially affected by the service. Moreover, permits members activated to defer motor vehicle insurance coverage for the period of active duty on one or more vehicles owned by the member if they certify that the vehicle will not be operated during the absence while on active duty. This bill is now Act 29 of 1992.
- 6. House Bill 1309 Provides for the observance of the third Friday in September of each year as "Pennsylvania POW/MIA Recognition Day." This bill is now Act 50 of 1992.


