## SPECIAL BENEFIT FOR GULF VETS

Each Memorial Day, Americans remember the men and women of the armed forces who have given their lives in service to the United States. Pennsylvania is proud of its veterans and offers a number of programs to help them and their families, but many who served in the first Persian Gulf War have not taken advantage of a program intended specifically for them.

The Persian Gulf Conflict Veterans' Benefits Program honors those on active duty in Desert Shield or Desert Storm from August 2, 1990, until Aug. 31, 1991, with a special, one-time payment. More than 7,200 individuals have applied, but approximately 20,000 Pennsylvanians are

eligible.

The program pays \$75 per qualifying month of active-duty service up to \$525. For personnel who were declared prisoners of war or who died through illness or injury received in the line of duty, an additional \$5,000 payment may be available to them or their surviving family.

# 'Fallen Heroes Ride' Will Honor Trooper/Marine

My name is Jeff Lutz and I am the president of Fraternal Order of Police Lodge # 75. On 7 June 2009 Pennsylvania State Police Trooper Joshua D. Miller was shot and killed while rescuing a nine-year-old boy who had been abducted at gunpoint by his estranged father. Josh leaves behind three children and a wife.

Josh was a proud Marine known to always motivate those around him. On 7 June 2009 at approxi-

mately 1037 hours he wrote "I will not let anything happen to my brothers on my watch" in an email to a fellow Trooper. At 2038 hours he was killed being FIRST to FIGHT, by being first in line to rescue a boy in harms way.

On 3 October 2009 the Fraternal Order of Police Lodge # 75 will be sponsoring a Fallen Hero's Motorcycle Ride in Honor of



As a veteran, you may qualify for burial benefits through the U.S. Department of Veterans Affairs, but it's important to understand what they are and how to request them.

According to funeral industry experts, many veterans don't know all the facts when they or their families come in to plan their funeral services. The pamphlet 10 Important Facts About Your VA Burial Benefits was created to educated veterans and correct some common misperceptions.

For example, a recent survey shows that 60% of veterans mistakenly believe the VA pays funeral, cremation and cemetery expenses for all veterans.

In truth, reimbursement of funeral or cremation expenses is limited, and certain restrictions apply. Six our of 10 veterans also believe caskets are provided free of charge to all veterans

Actually, neither VA nor the various services provide a free casket for a deceased veteran unless death occurs while on active duty.

These and other facts are explained in the pamphlet, which also contains information on requesting a U.S. flag, military funeral honors ceremonies, a Presidential Memorial Certificate and the issuance or replacement of military service medals, awards and decorations.


Adopt-A-Highway: The next highway cleanup will be held on October 17. More participation from Detachment members is necessary if the Detachment is to continue in the program.

# PTSD Compensation Rules Simplified

WASHINGTON--VA is taking steps to assist Veterans seeking compensation for Post-Traumatic Stress Disorder (PTSD).

"The hidden wounds of war are being addressed vigorously and comprehensively by this administration as we move VA forward in its transformation to the 21st century," said VA Secretary Eric K. Shinseki last month.

The VA is publishing a proposed regu-

lation today in the Federal Register to make it easier for a Veteran to claim service connection for PTSD by reducing the evidence needed if the stressor claimed by a Veteran is related to fear of hostile military or terrorist activity. Comments on the proposed rule will be accepted over the next 60 days. A final regulation will be published after consid-

Under the new rule, VA would not require corroboration of a stressor related to fear of hostile military or terrorist ac-

eration of all comments received.

tivity if a VA psychiatrist or psychologist confirms that the stressful experience recalled by a Veteran adequately supports a diagnosis of PTSD and the Veteran's symptoms are related to the claimed stressor.

Previously, claims adjudicators were required to corroborate that a non-combat Veteran actually experienced a stressor related to hostile military activity. This rule would simplify the development that is required for these cases.

PTSD is a recognized anxiety disorder that can follow seeing or experiencing an event that involves actual or threatened death or serious injury to which a person responds with intense fear, helplessness or horror, and is not uncommon in war.

Feelings of fear, confusion or anger often subside, but if the feelings don't go away or get worse, a Veteran may have PTSD.

VA is bolstering its mental health ca-

pacity to serve combat Veterans, adding thousands of new professionals to its rolls in the last four years. The Department also has established a suicide prevention helpline (1-800-273-TALK) and Web site available for online chat in the evenings at www.suicidepreventionlifeline.org/Veterans <a href="http://www.suicidepreventionlifeline.org/Veterans/">http://www.suicidepreventionlifeline.org/Veterans/</a>>.



# **DETACHMENT AWARDS CRITERIA**

#### Distinguished Citizens Medal (Bronze)

BACKGROUND: The Distinguished Citizens Medal (Bronze) is the highest medal which can be awarded at the Detachment level.

CRITERIA: Service to the Detachment, the Marine Corps, the Marine Corps League, or the community to an extraordinary degree is the major consideration for the award of this our most prestigious medal.

PRESENTATION: The medal is presented by the Detachment Commandant.

#### "Marine of the Year" Medallion and Ribbon

BACKGROUND: Being designated the Detachment "Marine of the Year" is the highest honor which can be bestowed upon a Detachment Member.

CRITERIA: This award is presented to a regular member of the Detachment who has rendered service(s) and performed a deed(s) above and beyond the duties and obligations required of a member of the Marine Corps League. Any meritorious deed(s) so identified as being within the scope of these rules shall be of such substance that the weight will or shall have brought acclaim and prestige to the Detachment, the Department, the Marine Corps League, and/or the Marine Corps; and/or furthered the concepts of the duties of being a citizen of the United States. Nominations must be submitted in writing, with supporting documentation, to the "Marine of the Year" Committee Chairman and must specify the extraordinary, superior performance(s) and/or deed(s) the nominee has demonstrated.

PRESENTATION: The medallion and ribbon are presented by the Detachment Commandant upon the recommendation of the award committee.

#### Distinguished Service Medal

BACKGROUND: The Distinguished Service Medal is the second highest medal which can be awarded at the Detachment level.

CRITERIA: Service to the Detachment, the Marine Corps, the Marine Corps League, or the community to an exemplary degree is the major consideration for this medal.

PRESENTATION: The medal is presented by the Detachment Commandant.

#### Detachment Recruiter Medal (Bronze)

BACKGROUND: The Detachment Recruiter Medal (Bronze) is awarded for recruiting.

CRITERIA: This award is presented to the member who recruits five or more members during the period June through May.

PRESENTATION: The medal is presented by the Detachment Commandant.

#### Community Service Ribbon

BACKGROUND: The Community Service Ribbon recognizes outstanding service to the veterans and/or civilian community.

CRITERIA: This award is presented to a member who has distinguished himself\herself in service to the community.

PRESENTATION: The ribbon is presented by the Detachment Commandant.

#### Meritorious Commendation Ribbon (Individual)

BACKGROUND: The Meritorious Commendation Ribbon (Individual) is the highest ribbon awarded at the Detachment level.

CRITERIA: Service to the Detachment, the Marine Corps, the Marine Corps League, or the community to an outstanding degree is the major consideration for the award. It may be awarded to an individual or a group of individuals working in consonance.

PRESENTATION: The ribbon is presented by the Detachment Commandant.

## PISC Statue to Get Another Makeover in its 7th Decade

One and a half times larger than life, the Iwo Jima Memorial at Marine Corps Recruit Depot Parris Island has served as the backdrop for countless photos of smiling parents, friends and family members, their arms draped proudly across the shoulders of their new Marine.

Few of them seem to notice that the statue -- depicting Associated Press photographer Joe Rosenthal's famous 1945 image of five Marines and one Navy corpsman raising the American flag on Mount Suribachi on Iwo Jima -- is melting before their eyes.

"It's made of some type of moldable plaster with a steel framework underneath," said David Woodward, an architect in Parris Island's engineering department. "We're not even really sure what kind of steel work is under there. It was never meant to be a permanent statue."

The plaster mold -- nearly a quarter of the size of the 300-ton, 32-foot-tall bronze Marine Corps War Memorial in Arlington National Cemetery -- was donated to Parris Island by Austrian-born sculptor Felix de Wheldon after World

#### Trooper Joshua D. Miller.

War II. One of two molds de Wheldon donated to the Corps, the statue arrived at Parris Island and was dedicated Sept. 5, 1952, on its current site near the depot's parade deck. The other mold was taken to Marine Corps Base Quantico, Va. Both molds, which de Wheldon built before the war memorial was even conceived, toured the nation with patriotic speakers to encourage Americans to buy war bonds during World War II, according to the Parris Island Museum.

For more than 50 years, the statue has stood along Boulevard de France battling the stifling Lowcountry humidity and frequent summer rains, elements that are beginning to deteriorate the iconic mold, Woodward said.

"When the rainwater gets inside the statue, the plaster gets kind of gooey, like toothpaste, and oozes out of the bottom of the statue," Woodward said. "Ideally, we'd like to see it moved indoors where it ceases to get wet and replaced with a bronze casting of the statue. The statue we have now is living on borrowed time."

Leroy Washington, the depot's supervising engineer technician, and his staff have been helping those five famous Marines and one famous corpsman keep the flag atop Mount Suribachi aloft for much of the last decade.

"We need to go out there again before the end of the year and caulk the joints, reseal the statue and put a fresh coat of paint on it," Washington said. 'It's been painted over at least three or four times that I can remember."

Over the years, workers have applied various coats of paint and protective seal-ant to shore up the cracks that inevitably form each year. An epoxy and paint mixture gives the monument its bronze hue.

Woodward said installing a permanent statue might be a job for the private sector or a community fundraising effort.

"A bronze casting will cost close to \$1 million," he said. "The Marine Corps and the Navy have bigger fish to fry. With all of the World War II veterans we have in our area, I wouldn't think it'd be very hard to get a drive going and raise enough money to commission a bronze mold."

In the meantime, Washington and his

staff will continue to apply paint, epoxy, caulk, rubber cement and whatever else they can to keep an important piece of the depot's history from melting in the sweltering South Carolina sunshine.

"We just have to work with what we have right now," he said.

## VA Assistant Secretary Raises Awareness About Post-9/11 GI Bill

WASHINGTON--"The Post-9/11 GI Bill throws open the doors of the country's colleges and university to Veterans," VA's **Assistant Secretary for Public & Governmental Affairs Tammy Duckworth** said last month in Vermont. "The Department of Veterans Affairs is working with those educational institutions to help Veterans improve their lives through education."

Duckworth attended an awareness-raising event at Champlain College, in Burlington, VT, with **Rep. Peter Welch**. She also traveled to Rutland to participate in a roundtable discussion at the Veterans of Foreign Wars Post.

The Post-9/11 GI Bill, passed by Congress last year, is the most extensive educational assistance program authorized since the original GI Bill was signed into law in 1944.

The bill, which takes effect August 1st, allows eligible veterans who served at least 90 days active duty since September 11, 2001, to receive an in-state, undergraduate education at a public institution at no cost. Under this new GI Bill, certain members of the armed forces may transfer benefits to a spouse or dependent children.

Additionally, the Yellow Ribbon Program, a provision of the Post-9/11 GI Bill, allows degree-granting institutions to voluntarily enter into a formal agreement with VA to fund tuition and fee expenses that exceed the highest public, in-state undergraduate rates. It provides for dollar-for dollar matching funds from VA to educational institutions for tuition for Veterans above the amount funded through the new GI Bill.

# Be Cautious About Giving Information to Census Workers

With the U.S. Census process beginning, the Better Business Bureau (BBB) advises people to be cooperative, but cautious, so as not to become a victim of fraud or identity theft. The first phase of the 2010 U.S. Census is under way as workers have begun verifying the addresses of households across the country. Eventually, more than 140,000 U.S. Census workers will count every person in the United States and will gather information about every person living at each address including name, age, gender, race, and other relevant data.

The big question is - how do you tell the difference between a U.S. Census worker and a con artist? BBB offers the following advice:

- \*\* If a U.S. Census worker knocks on your door, they will have a badge, a handheld device, a Census Bureau canvas bag, and a confidentiality notice. Ask to see their identification and their badge before answering their questions. However, you should never invite anyone you don't know into your home.
- \*\* Census workers are currently only knocking on doors to verify address information. Do not give your Social Security number, credit card or banking information to anyone, even if they claim they need it for the U.S. Census.

While the Census Bureau might ask for basic financial information, such as a salary range, the Census Bureau will not ask for Social Security, bank account, or credit card numbers nor will employees solicit donations.

Eventually, Census workers may contact you by telephone, mail, or in person at home. However, the Census Bureau will not contact you by Email, so be on the lookout for Email scams impersonating the Census.

Never click on a link or open any attachments in an Email that are supposedly from the U.S. Census Bureau.
