He would take them up in a jet that he was piloting. He would execute a roll and a dive from about 20,000 feet, then he would pull out of the dive just a few feet above the ground. He would then circle and land the jet.

After exiting the jet, he would have the trainee stand at attention while he inspected him. If the trainee did not have a load in his pants, then the trainee was allowed to continue in the program.

After a lot of laughter, I dropped him off at the Medical Records Department. I gave him a proper Marine Corps salute, which he acknowledged with a hand salute.
